RENTAL CONTRACT - TERMS & CONDITIONS

RESERVING EQUIPMENT & RENTAL CHARGES:

Rental items are subject to availability and equipment will only be reserved upon receipt of a signed contract. Quotes and proposals do not guarantee the availability of rental items. It is recommended that clients sign a contract no later than two-weeks prior to the scheduled event date. All individuals wishing to rent equipment are required to submit a 50% deposit (cash, check or credit card) along with a current, valid driver's license or state identification card at signing.

Client must provide SAVANNAH EVENT DECOR, INC. with final count 7 days prior to event at which time a final invoice with balance due will be provided. All rentals are to be prepaid, unless prior credit arrangements have been previously established. No orders will be scheduled for delivery until full payment is received. Cancellations or reductions must be made prior to seven days of your scheduled delivery or pickup date. Any cancellations or reductions thereafter will result in the loss of deposits paid pertaining to that specific item.

MISSING OR DAMAGED ITEMS:

A security deposit is required to be authorized on a valid credit card at time of signing. Charges billed to the credit card will consist of missing or damaged items or any additional charges incurred and left unpaid after 7 days of event. Items not returned within 7 days after the event will be considered missing. Missing or damaged rental items will be charged to the credit card at replacement cost. A detailed invoice of any charges and copy of client's credit card receipt will be mailed to the client.

SITE PREPARATION:

Event site must be set-up and ready, (lawns mowed, furniture moved, tables set-up, etc.) before the rental delivery is scheduled to arrive. If the site is not ready and accessible to delivery, the client may incur additional fees and/or equipment may not be delivered.

DELIVERY & SET UP:

SAVANNAH EVENT DECOR, INC. will strive to accommodate all client delivery requests; however, delays and changes in scheduling are sometimes unavoidable. We will try to communicate any scheduling changes as they occur. All rental items will be delivered and picked up at a designated location. The client or client's representative must be available to count all items upon delivery. The client or client's representative should be available to count all items upon pickup; otherwise, SAVANNAH EVENT DECOR, INC. counts will be considered accurate. Missing or damaged rental items will be charged to the credit card at replacement cost as previously indicated.

Our rental equipment is inspected on a regular basis in regards to its suitability of usage. As with any equipment, however, there is a risk that if it is not used as intended, injury could result. Dangerous behaviors such as leaning, jumping, running or playing on equipment should be discouraged. SAVANNAH EVENT DECOR, INC. assumes no responsibility for injury resulting from the misuse of any rental items or equipment. (See warranty disclaimer and indemnity clauses below) Client should provide any insurance or permits required for their particular event.

Client will be responsible for all rental items from the time of delivery and/or set up to the time of pick-up. Precautions should be taken to make sure the rental equipment is secured when not in use and protected from wind and water hazards such as inclement weather, outdoor sprinklers, pools, pets or any wet or damp surfaces that may damage rental items

CLEAN UP & PREPARATION FOR PICKUP:

All floral arrangements, decorations and other rental equipment should be placed in the designated delivered/pick-up location before scheduled pickup time. Returned rental items or floral arrangements that are permanently stained, burned, have holes or tears, are wet or damp with mildew, are covered with melted wax, or are otherwise unusable, will be billed at replacement cost. A cleaning fee will be assessed for any equipment that is unreasonably dirty upon being returned.

If we are forced to take legal action to recover our rental equipment, client agrees to pay for any and all legal fees, as well as charges for loss of use during the time the equipment is not in our possession.

DISCLAIMER OF WARRANTIES:

SAVANNAH EVENT DÉCOR INC., makes no warranty, express or implied, as to any matter whatsoever, including, without limitation, the condition of the rental equipment, its design, its capacity, its performance, its materials, its workmanship, its fitness for any particular purpose, or that it will meet the requirements of any laws, rules, specifications, or contracts which provide for specific apparatus or special methods. SAVANNAH EVENT DÉCOR INC., further disclaims any liability whatsoever, for loss, damage, or injury to client, or third parties as result of any defects, latent or otherwise, in the rental equipment.

INDEMNITY:

Client shall indemnify SAVANNAH EVENY DÉCOR INC., against and hold harmless from any and all claims, actions, suits, proceedings, costs, expenses, damages, and liabilities, including attorneys' fees, arising out of, connected with, or resulting from the rental equipment. Client recognizes and agrees that included in the indemnity clause, but not by way of limitation, is client assumption of any and all liability for injury, disability, and death to any person or persons in the use, control, or handling of any said rental equipment.

SUMMARY:

RESPONSIBILITY OF THE RENTAL EQUIPMENT REMAINS WITH THE CLIENT FROM THE TIME OF DELIVERY TO THE TIME OF PICKUP. Precautions should be taken to make sure that all rental equipment is secured when not in use and protected from weather. All collection fees, attorney fees, court costs, or any expense involved in the collections of rental charges will be the client's responsibility. All rental equipment must be returned according to these TERMS & CONDITIONS. The client is solely responsible for any additional charges incurred as a result of failure to meet these conditions. THE RENTAL OF THIS EQUIPMENT IS TO THE CLIENT INDICATED BELOW, FOR THE EVENT AND SPECIFIED DATE INDICATED ON THE PURCHASE INVOICE. THIS EQUIPMENT CANNOT BE SUBRENTED OR USED BY OTHERS, ONLY THE CLIENT SIGNING BELOW ON THIS CONTRACT.

IF ANY TERM OR PROVISION OF THIS CONTRACT IS FOUND INVALID, IT SHALL NOT AFFECT THE VALIDITY AND ENFORCEMENT OF ALL REMAINING TERMS AND PROVISIONS OF THIS CONTRACT.
